## 11. COLNE VALLEY RAILWAY

Mr Paul Lemon and Mr Nick Ellis of the Colne Valley Railway attended to explain the situation regarding the expiry of the lease on the land in December 2015. The landowner has been advised that the site would be considered for development by Braintree District Council, so has submitted it as a late entry in the call for sites for the new Local Plan. CVR are in constant contact with the landowner by phone, usually in the early morning as he is in Australia, and are contracted by him to dispose of the assets he owns, which are mostly railway carriages. Heritage Lottery Fund are urging CVR to continue with the grant application so they may be in a position to buy the land if possible when the draft Local Plan is completed by BDC. In the meantime they are talking to local landowners and are being enticed by developers to move elsewhere. The charitable aims of the railway state Colne Valley as the location and if at all possible the railway wishes to stay here, although other offers are attractive. Colne Valley Railway is the biggest tourist attraction in Braintree District, and there is strong support for the development of a museum. Two methods of protecting the site had been considered; registering it as an asset of community value and listing the station and the signal box. These options may be considered closer to the November deadline if other negotiations have not succeeded. Madam Chairman thanked the gentlemen for their time and reiterated that they have the full support of the Parish Council in staying at the current site.

The inaugural Heritage Walk takes place on 24<sup>th</sup> April. 14 people connected with the village celebrations will attend a lunchtime reception on 12<sup>th</sup> May at Mansion House to commemorate the 800<sup>th</sup> anniversary of the entry into London of the Baronial army.
